## European Environmental Legislation – RoHS (EU) Directive 2015/863

Hudson Technologies hereby certifies to the best of our knowledge based on the producing mill's test reports or other certification of compliance that our standard products are RoHS 3 compliant and do not exceed the designated levels of Lead, Cadmium, Hexavalent Chromium, Mercury, Polybrominated Biphenyls, Polybrominated Diphenyl Ethers, Bis(2-Ethylhexyl) phthalate, Benzyl butyl phthalate, Dibutyl phthalate or Diisobutyl phthalate legislated under the provisions of the European Parliament and Council Directive on the Restriction of the Use of Certain Hazardous Substances in Electrical and Electronic Equipment ((EU) 2015/863) and regulations promulgated thereunder, collectively, the "RoHS Regulations."

Registration, Evaluation, Authorization and Restriction of Chemical Substances (REACH)

Products manufactured by Hudson do not contain any of the chemicals listed in the REACH Substances of Very High Concern (SVHC) list greater than 0.1% wt/wt or substances listed in Annex XIV. The element Lead, included on the SVHC list, is present in concentrations of less than 0.1% wt/wt. Nickel is present in many of our products with the base metals listed below. Annex XVII of REACH entry 27 restricts the use of Nickel and its compounds in jewellery (including watches) and articles intended to come into contact with the skin. Hudson manufactures custom deep drawn metal enclosures, case, header and metal diaphragms.
